- 1. QUESTION Can you confirm that the thermal imaging is just for the renovated portion of the building (walls and roof)? ANSWER - Correction regarding third paragraph, change "addendum" to "Alternate'. "The school accommodates K – 4th grades with approximately 450 students. Construction Document Addendums # 2, 3, 4, 5 & 7 approved with addendum Alternates # 6 pending December 19th, 2017, include addendum Alternate #6 (AC) in your Commissioning proposal." Alternate #1, Administration Addition with associated Site Work not approved. There are no additions to this project.
- 2. QUESTION In the RFP you had ask for infrared imaging. Do you mean for just the roof (typical) or for the roofs and walls? ANSWER - In RFP request Building Envelope - Thermal

Imaging which includes all walls with roof edges that are renovated and roof areas where new equipment is installed.

- 3. QUESTION Can they provide the square footage to be scanned of each (it is not clear from the documentation that they sent)? ANSWER The existing school is noted as 61,400 SF on the PLAN FOR COMMISSIONING located at website above.
- 4. QUESTION For the page count, it states in the RFP "20 pages single sided" Can we submit 40 pages double sided? ANSWER Please submit per RFP.
- 5. QUESTION Can you confirm that we will submitting this via e-mail and not hard copy? ANSWER Yes see page 9 of 10. Proposals can be emailed for bidding by due date & time, However provide hard copy for filing.
- 6. QUESTION In the RFP it states "Include Addendum #6 (AC) in your Commissioning proposal. Addendum 6 was not posted on your website. Can you send this over? ANSWER Refer to question No. 1 above.
- 7. QUESTION Page 9 of the RFP states "Use the fee table to provide fees". There was no fee table given. Can you provide a fee table that you would wish for us to include in the proposal? ANSWER Use table just below on same page.

All task amounts include associated meetings, progress reports and direct costs (travel, mileage, etc.). Use the fee table to provide fees. Also provide an hourly rate for each team member for work that may exceed the scope.
